Course Registration Instructions:

1. Read application and waiver forms in their entirety.
2. Complete and Review the forms.
3. Sign all forms and have two witnesses sign the Waiver form as well.
4. Turn in completed forms, in person, to the:

Course Requirements:

1. Each Participant must provide a Revolver or Semi-Automatic Pistol, with 50 rounds of ammo.
 - a. Weapons **must** function properly and safely when inspected by **FCSO Instructors**.
 - b. Weapons **must** be .38, .380, 9mm or .40 cal. (**ONLY**)
 - c. Ammunition **must** be "BALL" type ammo. (**NO HOLLOW POINTS**)
2. Each Participant **must** provide approved hearing and vision protection.
3. Each Participant must attend every class/lecture prior to attending the **FIRING RANGE**.
4. All classes will be three (3) consecutive Tuesday evenings from 6-8 pm and Saturday (following the last class/lecture) from 9am-12 noon. The FCSO will offer these classes periodically as time and resources permit. Please ensure you will be able to attend all three (3) of the classes/lectures. If not, you will **not** be permitted to attend the **FIRING RANGE** on Saturday.

Floyd County Sheriff's Office Women's Firearms Safety Course WAIVER, RELEASE AND INDEMNIFICATION

The Floyd County Sheriff's Office conducts a course known as the "**Women's Firearm Safety Course**", open to local female citizens. The class is conducted by Floyd County Sheriff's Office personnel and is designed to provide the Participant with a basic understanding and familiarization of Georgia Gun Laws, Firearms Safety, Function and Operation. The classroom instruction will be provided at the Floyd County Jail, in the Training Office and the LIVE FIRE will be at the Floyd County Firing Range, located behind the County Prison off Blacks Bluff Road. In consideration for the privilege and benefits to be derived from participating in the "**Women's Firearm Safety Course**", Sheriff Burkhalter is requiring all participants therein to execute this waiver, release and indemnification.

Participation in the "**Women's Firearm Safety Course**" classes may involve physical activities such as, but not limited to, lifting, walking, bending, kneeling, riding, the discharge of firearms and will include risks such as falls, interaction with other participants, effects of weather, the physical conditions of the facilities and features and equipment located thereon, together with the inherent risks of being in close proximity to the discharge of firearms. Participant expressly assumes these and all other risks arising in any way out of Participant's involvement in "**Women's Firearm Safety Course**" activities; including any transportation provided to, from and between such activities. Participant represents and warrants herself to be physically fit and able to participate in such activities, and agrees to stop and request assistance if experiencing any symptoms or other conditions which would make it difficult or unsafe to continue; further understanding that Participant is solely responsible for their own health and safety. Participant of the "**Women's Firearm Safety Course**" understands that at all times, the privilege of their participation shall be governed by the Floyd County Sheriff's Office, Division of Professional Development and Participant will abide by and follow any directions given by the Floyd County Sheriff's Office Training Instructors.

On behalf of Participant's self, heirs, executors and assigns, Participant does hereby waive and personally assumes any and all risks and liability for damages, losses, personal injuries or death which Participant might suffer, sustain or cause while participating in any activities of the "**Women's Firearm Safety Course**" and Participant does hereby release and forever discharge the Sheriff and the Floyd County Sheriff's Office, the County of Floyd County, Georgia, all, officers, agents, employees representatives and other personnel (in their official and individual capacities) (collectively, the "Releasee") from any and all claims, demands, actions, damages, or suits at law or equity of whatever nature which Participant has or may hereafter acquire against the "Releasee" as a result of Participant's voluntary participation in the afore described activities, and Participant hereby holds harmless and agrees to indemnify "Releasee" for all damages, attorney's fees and costs which may be incurred in defending any such demands, claims, actions and the like.
